### **Battery Component Warranty Agreement**

What is a lithium battery warranty service?

Class 3 (types A and B) and Class 4 power grids are harsh power grid environments. The warranty service is the product assurance serviceprovided within the product warranty scope to resolve lithium battery quality issues. The service includes help desk,remote troubleshooting, and lithium battery spare parts replacement.

What happens if a lithium battery fails during the warranty period?

Faulty parts replacement: During the warranty period, if an individual failure is caused by the lithium battery quality problem of Party B, Party B is responsible for delivering qualified parts to the receiving place agreed by both parties within the committed service level agreement (SLA).

When does a product warranty start?

The product warranty starts from the date when the preliminary acceptance certificate is issued, the date when the product is put into commercial use, or the date when the product is put into operation on the network, whenever earlier. Scenario 2: Party B is responsible for product installation.

What is included in the battery assist service?

The supply of a replacement battery and the labour required to fit the battery to the Vehicle. A warrantyfor the Battery Assist Service is included on all parts and labour provided in accordance with clause 12 of the General Terms of Contract ("Our Warranty"). Any additional parts and labour which might be required to fix the Vehicle.

What are the terms & conditions of the battery assist service?

The contract governed by these Terms and Conditions is made between You and the AA. The Battery Assist Service is available 7 days a week (excluding Christmas Day, Boxing Day and New Years Day) 24 hrs per day.

Can extended warranty be provided within the service life?

Extended warranty can be provided within the service lifeand needs to be quoted. Subject to the feedback from the local spare parts contact person. Note: The SLA in the table is the standard warranty services. Warranty improvement services can be provided and quoted based on requirements of Party A.
