Do I need a label for lithium ion batteries?

If you're shipping lithium ion batteries contained in or packed with equipment, use a battery label with UN3481. Lithium metal batteries will use labels with one of the following UN numbers: If you're shipping lithium metal batteries as a standalone (no other items in the package), use a battery label with UN3090.

Do I need a DG label for a lithium ion battery?

DG Handling Label - Caution! Lithium Batteries - Ion Required by International Air Transport Association(IATA) on certain types of Lithium Ion Batteries. See Shipping lithium batteries.

What is a lithium battery label?

Labels are printed with the letters 'UN' and a 4-digit number. Think of it like a special code. These numbers clarify 2 types of crucial information: the lithium battery type and packaging method. Packaging method refers to how the lithium batteries are being shipped. This can be done in 3 ways:

What is a'standalone' battery label?

Standalone means the package only contains batteries and nothing else. If you're shipping lithium ion batteries contained in or packed with equipment, use a battery label with UN3481. Lithium metal batteries will use labels with one of the following UN numbers:

How do I label a lithium battery?

Except when lithium cells (<1g) or batteries (<2g) are packed with or contained in equipment in quantities not exceeding 5kg net weight,the outer package must be marked:: "LITHIUM METAL BATTERIES - FORBIDDEN FOR TRANSPORT ABOARD PASSENGER AIRCRAFT". The orange Cargo Aircraft Only label can be used as an alternative in the 48 contiguous states.

How do I label a battery package?

Apart from the specifications issued by governing authorities and the carrier, you must follow general labelling guidelines for all battery packages. The outer box must have the UN number, proper shipping name (e.g. UN 3480, Lithium-ion batteries), and hazard labels. Use laminated labels to prevent damage from condensation.
