Do mobile manufacturers offer a warranty on rechargeable batteries?

Mobile manufacturers offer a warranty on smartphones. But often the warranty for rechargeable batteries is shorter than for the whole device.

Do rechargeable batteries have a shorter warranty period?

We have asked and looked and found that many manufacturers give a shorter warranty period for rechargeable batteries than for the whole device. This is annoying, because on almost all smartphones the battery can only be replaced with a complicated repair.

How long does a battery last under warranty?

12 monthsif removable. Otherwise like device. And just because your device shows battery damage within the specified period of time, you are not entitled to a replacement under warranty. Some manufacturers like Apple declare batteries as expendable parts and therefore as an exception to the warranty conditions.

What are the new regulations on batteries?

The new Regulation on batteries establish sustainability and safety requirements that batteries should comply with before being placed on the market. These rules are applicable to all batteries entering the EU market, independently of their origin.

When will user-replaceable batteries be available in the EU?

It contains similar rules about making smartphone batteries easier to replace and is expected to come into effect earlier in June or July 2025. So by the time 2027rolls around, some smartphone manufacturers may have already been selling devices with user-replaceable batteries in the EU for over a year.

What if a phone battery is not replaced under warranty?

If the manufacturer does not replace the battery under warranty, this is not too bad. Thanks to the warranty laws, you can go to the store where you bought the phone for 24 months from the date of purchase. There, repairs are either possible directly or the dealer will help you find a workshop.
