How much does the Czech government pay for solar panels?

Thousands of households, small businesses and international investors took out loans to install solar panels that are in many cases still being repaid. The government pays about EUR1bn to EUR1.2bnin subsidy support annually, according to the Czech Solar Association.

Will the Czech Republic invest in solar power?

The Czech Republic will have hard time looking for someone willing to invest in the sector," the Czech Solar Association Chairman Jan Krcmar said. Majority state-owned electricity producer CEZ (CEZP.PR) plans to invest \$4.15 billion - four times its 2020 profit - into building 6 gigawatt of solar power capacity by 2030.
