How long does it take to arbitrate a commercial dispute in Moldova?

Arbitrating Commercial Disputes: on average, it takes 13 weeks to enforce an arbitration award rendered in Moldova, and 21 weeks for a foreign award. Foreign and domestic investors are treated equally. Moldova ratified the ICSID Convention on the Settlement of Investment Disputes between States and Nationals of Other States in 2011.
