What is the return policy for batteries?

The return policy is that you must return batteries within 30 daysof receipt for a full refund or exchange. However, some batteries are non-returnable but you'll still be able to seek a refund if they're defective. We'll cover below how to identify batteries that are non-returnable. Can I return a battery if I have a problem?

However,if your batteries have developed a fault outside the 30-day window, then definitely still reach out to them. Amazon is usually great with returns, especially when it comes to defective products and they'll often just send out a replacement without too much fuss.

Can I return a battery to Amazon?

The strict wording of Amazon's policy is that items be returned in "like-new" condition with all of their accessories. If your battery/batteries can be returned then there's only one way to do so and that's using Amazon's online returns process. Can I ship a lithium ion battery?

Note about shipping lithium ion batteries: Kindle e-reader and Fire tablet batteries are considered " lithium ion batteries contained in equipment " under dangerous goods transportation regulations and do not require special labeling or documentation two or fewer devices are shipped in a single package.

What if I miss a battery from Amazon?

If you've purchased batteries from Amazon but perhaps they're poor quality, an unwanted gift or you've simply changed your mind, then you'll need to act quickly to make a return. Most companies have a limited returns window in which to return products for a full refund or exchange and if you miss it, you might be stuck with the product.

How long does a battery last on Amazon?
