The Batteries Regulation is a new regulation that sets requirements for batteries and waste batteries placed in the EU market. It covers all types of batteries unless an exemption applies. In this guide,we explain when the regulation will begin to apply, and its differences from the prior Batteries Directive.

What are the UK battery regulations?

The Regulations set out requirements for waste battery collection, treatment, recycling and disposal for all battery typesincluding arrangements by which the UK intends to meet portable battery collection targets of 25% by 2012 and 45% by 2016.

How long does a battery exemption last in the UK?

However, the exemption for power tools is subject to review after four years. Collection targets for spent portable batteries of 25% of average annual sales 4 years after the directive is implemented in the UK, rising to 45% after 8 years. Bans the disposal of untreated automotive and industrial batteries in landfill or by incineration.

Who is affected by battery regulations?
