

What is a tax code?

Each tax code is a combination of numbers and letters that tell your employer or pension provider how much tax-free income you are entitled to. Here's everything you need to know about tax codes, including how to decode yours, why they may change, and what to do if it's incorrect. Your tax code is made up of numbers and letters.

What are emergency tax codes?

Emergency tax codes are temporary, and HMRC will update them once they have the correct information. Tax codes starting with K mean you have income that's not being taxed elsewhere, and its value exceeds your tax-free allowance.

What does a 'k' tax code mean?

Tax codes with 'K' at the beginning mean you have income that is not being taxed another way and it's worth more than your tax-free allowance. For most people, this happens when you're:

What is a letter L tax code?

The letter L tells the employer to charge tax at the basic, higher or additional rate depending on an individual's income. If everyone's tax affairs were straightforward, everyone would have a tax code of 1250L and everyone would pay the right amount of tax each year without the need for end-year adjustments, filling in tax returns etc.

What is a S0T SD0 SD1 SD2 tax code?

S0T, SD0, SD1, SD2: These codes are prefixed with 'S' for Scottish taxpayers. The numbers correspond to the same rules as 0T, D0, D1, and so on. C: Custom tax code used when your tax deduction is not standard, often resulting from specific circumstances communicated by HMRC.

What is a tax code based on a personal allowance?

In the simplest case, an individual will have a tax code based around the full tax-free personal allowance of £12,500 per year. HMRC knocks off the final digit and adds a letter code to give information to employers about how much tax to deduct. The most common tax code in 2020/21 will be 1250L.
