Do solar products qualify for zero import duty in Nigeria?

Solar products imported into Nigeria do not qualify for zero import duty. Although the outright limitation of this policy on imports may not be conspicuous, it does encourage higher market prices that deter rapid solar power adoption by consumers, especially low income consumers.

What is the duty remission for solar equipment in Kenya?

Earlier in 2011,duty remission was granted for the import of raw materials used in solar equipment manufacturing in Kenya. This was meant to help improve the competitiveness of locally made products. The duty remission was a strategic shift away from the existing 25% duty on such products.

Who should be contacted when importing or exporting electricity?

The regional Distribution Network Operators(DNOs) must be contacted when permission is required for certain higher-power devices which import or export electricity. These include PV Solar Panels, Home Battery Storage, Wind Turbines, Electric Vehicle chargers and Heat pumps. Export:

What is the VAT rate for solar in Kenya?

In 2014,the Kenyan Government lifted all Value Added Tax (VAT) charges on imported solar products, overriding an existing 16% VAT charge. This undoubtedly helped spur the import market and has been one of the fundamental contributors to Kenya's leading position in solar power adoption. Import duty for solar products in Kenya is also zero (0) %.
